



## RULES

**Only 50,000 tickets will be sold.**

- \$100 each, 3-pack for \$250, 5-pack for \$375, Super Pack for \$525 (includes 6 – Home Lottery tickets, 15 – 50/50 Add-On® tickets and 6 – 100 Days of Winning® Cash Calendar™ Add-On tickets).
- All tickets in a 3-pack, 5-pack or Super Pack and all Add-Ons in a 3-pack, 5-pack, 6-pack or 15-pack must contain the same name and contact information. Only one method of payment will be accepted, only one mailing address will be recorded, and only one envelope will be mailed containing all tickets.
- 50/50 Add-Ons must be ordered in conjunction with your Hospital Home Lottery ticket. 50/50 Add-On orders will not be accepted after your original Hospital Home Lottery ticket order date.
- 100 Days of Winning Cash Calendar Add-Ons must be ordered in conjunction with your Hospital Home Lottery ticket. 100 Days of Winning Cash Calendar Add-On orders will not be accepted after your original Hospital Home Lottery ticket order date. There are 100 prizes in the 100 Days of Winning Cash Calendar with a total prize value of \$124,000

### DRAW ORDER

Only tickets purchased before the Bonus deadline of midnight, October 11, 2019, are eligible for the Bonus prizes. The Bonus draws will commence between 9:00 – 10:00 a.m. on October 22, 2019. The Bonus Prize winners will be announced on the lottery website on October 22, 2019.



\*Only tickets purchased before the Early Bird deadline of midnight, November 8, 2019, are eligible for the Early Bird prize. In the event that all tickets are sold by the Early Bird Prize deadline, then all draws will commence between 9:00 – 10:00 a.m. on November 19, 2019. The first draw will be for the Early Bird Prize followed by draws for all remaining prizes starting with the prizes of least retail value. The top prize winners will be announced on CTV on November 21, 2019. The 50/50 Add-On and 100 Days of Winning Cash Calendar draws commence on November 19, 2019, following the Grand Prize draw. 100 Days of Winning Cash Calendar winners will be announced daily beginning December 15, 2019.

\*\*In the event that tickets remain after the Early Bird deadline, then the Early Bird Prize draw will commence at 9:00 a.m. on November 19, 2019. Final ticket sales deadline is midnight, November 22, 2019. All remaining draws will commence on December 3, 2019 between 9:00 – 10:00 a.m. at the offices of Deloitte LLP. Draws will proceed in order of retail value beginning with the prizes of least retail value. The top prize winners will be announced on CTV on December 5, 2019. The 50/50 Add-On and 100 Days of Winning Cash Calendar draws will commence on December 3, 2019, following the Grand Prize draw. 100 Days of Winning Cash Calendar winners will be announced daily beginning December 15, 2019.

After each draw, including the Bonus and Early Bird draws, the winner is recorded, and the ticket number goes back for the next draw. Each ticket purchased before the Bonus deadline is eligible for 1,625 draws. Each ticket purchased after the Bonus deadline but before the Early Bird deadline is eligible for 1,621 draws. Tickets purchased after the Early Bird deadline will be eligible for the remaining 1,620 draws.

#### DRAW PROCESS

All prize draws are performed manually, as required by the licensing body (Department of Public Safety).

Prize draws follow a strict set of procedures, with draw control oversight by Deloitte LLP, and under licensing approval by the licensing body.

Each prize draw will select one (1) winner and that winning token is selected from the draw drum at random. After each draw, including the Bonus Prize and Early Bird draws, the winner is recorded, and the ticket number goes back for the next draw.

In the instance where multiple tokens are inadvertently selected from the draw drum, and this is identified prior to the reading of the token number, Deloitte LLP will halt the draw immediately, tokens will be returned to the drum, and the draw procedure will be performed to determine one (1) winner.



In the event that multiple tokens are inadvertently pulled from the draw drum, and this is not identified prior to identifying and reading of the token number, the token number read aloud, confirmed and recorded is deemed to be the first token pulled and therefore established as the valid winner.

A draw will only be deemed valid and complete upon final confirmation and recording by Deloitte LLP.
